

**AMENDMENT NO. 1  
TO AGREEMENT BY AND BETWEEN  
MONTEREY COUNTY WATER RESOURCES AGENCY &  
WEST YOST ASSOCIATES, INC.**

**THIS AMENDMENT NO. 1** is made to the PROFESSIONAL SERVICES AGREEMENT for the provision of Professional consulting services by and between **WEST YOST ASSOCIATES, INC.**, hereinafter “CONTRACTOR”, and the Monterey County Water Resources Agency, a political subdivision of the State of California, hereinafter referred to as “Agency”.

**WHEREAS**, CONTRACTOR entered into an Agreement for Services with the Agency on May 1, 2023 (hereinafter, “Agreement”); and

**WHEREAS**, the Agency and CONTRACTOR wish to amend the AGREEMENT to reflect a term extension of two (2) months, to continue providing services identified in the Agreement; and

1. Amend Section 2, “**Term of Agreement**” to read as follows:

**Term of Agreement.** The term of this agreement shall begin on **May 1, 2023**, by CONTRACTOR and Agency, and will terminate on **June 30, 2024**, unless earlier terminated as provided herein.

2. All other terms and conditions of the Agreement remain unchanged and in full force.
3. A copy of this AMENDMENT NO. 1 shall be attached to the original AGREEMENT dated May 1, 2023.
