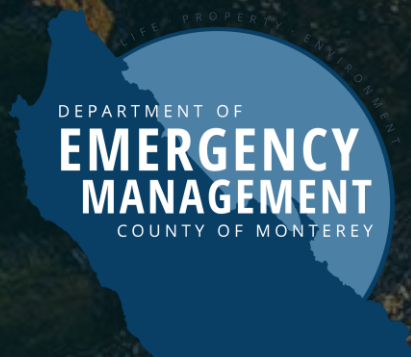

Resilience Planning - **Complete**

Coordinate with key stakeholders to identify the organization's resilience challenges and goals.



Project Scoping

Lead the development of a comprehensive strategy, including the populations and infrastructure that are most vulnerable, and incorporates planning and implementation of mitigation, preparedness, and recovery activities, and mitigation project scoping.



Subject Matter Expertise

Contribute knowledge and expertise to continuously improve and implement the applicant organization's resilience strategy.



Secure Funding

Identify and secure funding, such as Hazard Mitigation Assistance (HMA), over the period of performance that aligns with the applicant organization's resilience strategy and can ensure its continued success.

Recommendations



a. Authorize the Director of Emergency Management and/or designee to execute a Grant Agreement with the California Office of Emergency Services (CalOES) accepting a grant award of \$993,038 for deploying a Chief Resilience Officer and Community Resilience Coordinator and implementing the Prepare California Jumpstart Initiative for the grant period of August 1, 2023, through June 30, 2028; and

b. Approve an increase in appropriations and estimated revenues for the first year of the 5-year performance period of \$198,000 for the Department of Emergency Management Budget Unit 001-1040-DEM001-8588 Adopted Budget (4/5ths vote required)
