Approving and Adopting the Local Road)
Rehabilitation Program v.2.0 Policy for)
inclusion in the Board Policy Manual)

WHEREAS the Monterey County Board of Supervisors is interested in increasing the Pavement Condition Index of County roads to at least a “Fair” standard by 2032; and

WHEREAS the total centerline mileage of county-maintained roads across all classifications is approximately 1263 miles, which includes over 700 miles of local roads. The overall Pavement Condition Index (PCI) for the County Roads system in 2022 was 40 (where ‘50’ is desirable for a Fair rating); however, the local roads overall PCI was only 36; and

WHEREAS County Road repair funding has historically been primarily directed toward County roads with higher traffic volumes and a greater proportion of truck traffic- roads on key transportation, agriculture, or tourism corridors; however, to achieve an overall system PCI of “Fair” by 2032, deferred maintenance for local roads must also be included in the County’s regular road maintenance and repair program; and

WHEREAS on January 30, 2024, the Board received an update on the status of a proposed Local Road Rehabilitation Program, along with a recommended ‘pay as you go’ (PAYGo) financing approach and proposed an initial pilot 10-year plan; and

WHEREAS the Board Supported implementation of the recommended financing plan for the Local Road Rehabilitation Program, approved the initial local road repair plan, and directed that staff return with a formal Policy for the Local Road Rehabilitation Program v2.0 to set out the fundamental framework, tenets, and policies/priorities for adoption and inclusion in the Board Policy Manual (with implementation starting Fiscal Year 2024-25); and

WHEREAS staff prepared the attached Local Road Rehabilitation Program v2.0 Policy for Board consideration and adoption.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey that the Local Road Rehabilitation Program v.2.0 Policy, attached hereto, is approved for inclusion in the Board Policy Manual.


