WHEREAS, Susan Gleason was the Archer Child Advocacy Center (ACAC) Coordinator at the Bates-Eldredge Clinic for 17 years; and

WHEREAS, Susan Gleason, for thirty-two years, has provided quality child welfare services, including Emergency Response, ACAC Coordinator, and Adoptions, to the families and children in Monterey County; and

WHEREAS, Susan Gleason has consistently demonstrated her commitment to the safety and well-being of children by providing forensic interviews and professional assessment and thoughtful case consultation and management services; and

WHEREAS, Susan Gleason received Commendation Letters for her ‘Conscientious and Particularly Outstanding Work on a difficult case’ on June 6, 1990 by the DA Office, Outstanding Work Beyond Call of Duty on September 9, 1992, and her Expertise of Forensic Interviewing on March 3, 2007 by Family and Children Services Deputy Director Robert Taniguchi; and

WHEREAS, Susan Gleason was a member of the Northern California Network of Advocacy Centers, provided Child Abuse Response Team (CART) trainings, facilitated Sexual Assault Response Team (SART) meetings, and a Sexual Abuse Specialist since 1988; and

WHEREAS, Susan Gleason was instrumental in obtaining national accreditation of the Archer Child Advocacy Center by the National Children’s Alliance and working alongside Dr. Valerie Barnes in making this accreditation possible; and

WHEREAS, Susan Gleason has announced her intent to retire from public service on September 27, 2019;
