**WHEREAS**, each year the County of Monterey and the Monterey County Veterans Services Advisory Commission honors those who have made a significant contribution to their communities, are strong motivators, have demonstrated extraordinary professional competence and are role models for veterans and the community as a whole; and,

**WHEREAS**, after his military service **Terry Kaiser** was hired by the Monterey County Sheriff’s Office where he began a long career of public service; and,

**WHEREAS**, **Terry Kaiser** was sworn in on September 10, 1970 by Sheriff Jack Davenport and over his forty-eight and a half years of service he served seven Monterey County Sheriffs: Jack Davenport, D.B. “Bud” Cooke, Norman G Hicks, Gordon Sonn , Mike Kanalakis, Scott K. Miller and Steve Bernal; and,

**WHEREAS**, **Terry Kaiser**, retired from Monterey County Sheriff’s office in April 2019 after 48.8 years of service, which may be the longest service record ever held by a law enforcement officer in the State of California.

**NOW, THEREFORE BE IT RESOLVED THAT**, the Monterey County Board of Supervisors, on behalf of the County and all residents thereof, honors **Terry Kaiser** as a 2019 Monterey County Veterans Services Advisory Commission’s “Veteran of the Year” and wishes him continued success, peace and happiness in all his future endeavors.
