WHEREAS, **Rene Cantú** began his career with Monterey County on October 24, 1977 at Natividad Medical Center as a Typist Clerk II, where he replied to correspondence, handled billing disputes, civil suits and assisted with inpatient and outpatient registration; and

WHEREAS, **Rene Cantú**, received a competitive promotion to an Account Clerk on November 17, 1979 at Natividad Medical Center where he continued to be of great value to Natividad by posting patient payments, researching insurance and Medicare payments, and by confirming Medi-Cal coverage; and

WHEREAS, on August 22, 1981, **Rene Cantú's** position as an Account Clerk was reclassified to Medical Insurance Clerk, where his knowledge and expertise allowed him to greatly assist others and he received the nickname "trouble shooter;" and

WHEREAS, **Rene Cantú** on May 17, 1982, accepted a position in the Revenue and Recovery Division of General Services as a Revenue Recovery Specialist, specializing in Natividad Medical Center collections and professionally representing the county on numerous cases; and

WHEREAS, on March 1, 1997, **Rene Cantú**, continued to excel in the collection of debts owed to the County of Monterey in the Revenue Division of the Treasurer-Tax Collector's Department and was reclassified to a Revenue Officer I; and

WHEREAS, **Rene Cantú** on July 5, 1997, received a promotion to a Revenue Officer II and aggressively investigated liens, represented the county in small claims court, collected Monterey County Superior Court criminal and traffic fines and fees, and continued to collect debt for numerous county departments including Probation and General Services; and

WHEREAS, **Rene Cantú** has chosen to retire from Monterey County after thirty-seven years of service, effective December 31<sup>st</sup>, 2014, let it be known that his dedication and professionalism will be remembered and appreciated by those who worked with him over the years.
