WHEREAS, the California Department of Transportation certified to the State Controller in the year 2017 that the total mileage of Monterey County maintained roads was 1,232.38 miles; and

WHEREAS, the Board now finds the total mileage of Monterey County maintained roads is 1,257.72 miles in accordance with the additions, exclusions or corrections to the tabulation as indicated in EXHIBIT 1 - SUMMARY SHEET 2018 MILEAGE OF MAINTAINED COUNTY ROADS MONTEREY COUNTY for the year 2018, attached hereto and incorporated by this reference as a part of this resolution; and
