the lives of adults with mental illness

**WHEREAS, Jan Klinefelter** was one of the first staff members at Interim Inc., starting her career as a counselor at the initial Monterey “halfway house”; and

**WHEREAS, Jan Klinefelter** is to be commended for creating a solid community program at Shelter Cove, a transitional housing program for thirty-six homeless adults living with psychiatric disabilities; and

**WHEREAS, Jan Klinefelter** added Sandy Shores to her responsibilities in 2004, providing permanent, affordable housing for twenty-eight homeless adults living with psychiatric disabilities; and

**WHEREAS, Jan Klinefelter** is Program Director for both the Shelter Cove and the Sandy Shores programs; and

**WHEREAS, Jan Klinefelter** previously directed the Elm House, a transitional residential treatment program in Seaside and the Pajaro House, a similar program in Salinas; and

**WHEREAS, Jan Klinefelter** has always believed strongly in social rehabilitation and recovery and has been a champion for clients, urging people with psychiatric disabilities to be active in the community and achieve their goals; and

**WHEREAS, Jan Klinefelter’s** strengths are her passion for adhering to the values and philosophy of social rehabilitation, and for her advocacy for clients in helping individuals build a supportive, caring, inclusive community; and

**WHEREAS, Jan Klinefelter** encourages people to be interdependent and to support each other in achieving their ultimate dreams.

**NOW, THEREFORE BE IT RESOLVED** that the Monterey County Board of Supervisors, on behalf of the County and all citizens thereof, honors **Jan Klinefelter** for her outstanding service, exceptional dedication, and many contributions throughout her career at Interim Inc., and wishes her continued success, peace, and happiness in all of her future endeavors.
