**RESOLUTION NO.17-356**

Amending the 2017-18 Budget to incorporate a list of )  
projects funded by SB 1: The Road Repair and )  
Accountability Act..... )

**WHEREAS**, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 in order to address the significant multi-modal transportation funding shortfalls statewide; and

**WHEREAS**, SB 1 includes accountability and transparency provisions that will ensure the residents of Monterey County are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

**WHEREAS**, Monterey County must include a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, in the Monterey County budget, which must include a description and the location of each proposed project, a proposed schedule for the project’s completion, and the estimated useful life of the improvement; and

**WHEREAS**, Monterey County, will receive an estimated \$2,853,817 in RMRA funding in Fiscal Year 2017-18 from SB 1; and

**WHEREAS**, Monterey County has undergone a robust public process to ensure public input into our community’s transportation priorities/the project list; and

**WHEREAS**, Monterey County developed the SB 1 project list based on its 2015 Pavement Asset Management Plan to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities’ priorities for transportation investment; and

**WHEREAS**, the funding from SB 1 will help Monterey County maintain and rehabilitate roads throughout the County this year and other similar projects into the future; and

**WHEREAS**, the 2016 California Statewide Local Streets and Roads Needs Assessment found that the County’s streets and roads are in “poor” condition and RMRA revenue will help increase the overall quality of the road system and, over the next decade, will bring streets and roads into a “good” condition; and

**WHEREAS**, without revenue from SB 1, Monterey County, would have otherwise been deferring and/or canceling projects throughout the County and/or laying off County staff; and

**WHEREAS**, if the Legislature and Governor failed to act, city streets and county roads would have continued to deteriorate, having many and varied negative impacts on the community; and

**WHEREAS**, the County of Monterey owns and maintains approximately 1200 centerline miles of roads and 174 bridges that the people and traveling public depend on for a safe, reliable local transportation network; and

**WHEREAS**, modernizing the local street and road system provides well-paying construction jobs and boosts local economies; and

**WHEREAS**, the local street and road system is also critical for farm to market needs, interconnectivity, multimodal needs, and commerce; and

**WHEREAS**, police, fire, and emergency medical services all need safe reliable roads to react quickly to emergency calls and a few minutes of delay can be a matter of life and death; and

**WHEREAS**, maintaining and preserving the local street and road system in good condition will reduce drive times and traffic congestion, improve bicycle safety, and make the pedestrian experience safer and more appealing, which leads to reduced vehicle emissions helping the State achieve its air quality and greenhouse gas emission reduction goals; and

**WHEREAS**, restoring roads before they fail also reduces construction time which results in less air pollution from heavy equipment and less water pollution from site run-off; and

**WHEREAS**, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

**NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND** by the Board of Supervisors of the County of Monterey, State of California, as follows:

1. The foregoing recitals are true and correct.
2. The \$42,539,672 Road Fund, Appropriation Unit RMA012 budget for fiscal year 2017-18 is amended to incorporate the following list of projects planned to be funded with Road Maintenance and Rehabilitation Account revenues:

3. The \$42,539,672 Road Fund, Appropriation Unit RMA012 budget for fiscal year 2017-18 is amended as follows:

Increase revenues and appropriations in the FY 2017-18 adopted budget, Road Fund 002, Appropriation Unit RMA012 by \$2,853,817, funded by Senate Bill 1 (SB1 Beall) – the Road Repair and Accountability Act of 2017, Road Maintenance and Rehabilitation Account.
