Approve and authorize the Director of Health Services or designee to execute Amendment No. 8 to extend the Paramedic Service Provider Agreement between the County of Monterey and Monterey County Regional Fire District on the same terms and conditions by twelve (12) months for the term of March 28, 2012 to June 30, 2026.

RECOMMENDATION:

It is recommended that the Board of Supervisors:

Approve and authorize the Director of Health Services or designee to execute Amendment No. 8 to extend the Paramedic Service Provider Agreement between the County of Monterey and Monterey County Regional Fire District on the same terms and conditions by twelve (12) months for the term of March 28, 2012 to June 30, 2026.

SUMMARY/DISCUSSION:

The Emergency Medical Services (EMS) Agency is designated under California law by the County of Monterey as the local Emergency Medical Services Agency responsible for planning, implementing, and evaluating the local EMS system throughout the County of Monterey. Under California law, no person or organization may provide “advanced life support,” also known as “paramedic services,” unless that person or organization is an authorized part of the emergency medical service system of the local EMS agency.

Accordingly, under California law, a paramedic service provider must have a written agreement with the local EMS agency to participate in the EMS system and to comply with all applicable state regulations and local policies and procedures, including participation in the local EMS agency’s Continuous Quality Improvement (“CQI”) program.

The original Paramedic Service Provider Agreement was reviewed and approved by the Emergency Medical Care Committee (EMCC) on September 14, 2011, and by the County of Monterey Board of Supervisors on November 1, 2011. The current Agreement expires on June 30, 2025.

Amendment No. 8 extends the Agreement until June 30, 2026, under the same terms and conditions. The Monterey County Regional Fire District and the EMS Agency are in the process of executing a new Paramedic Service Provider Agreement to incorporate recent changes in regulation. The extension is needed to provide additional time to review the new agreement to ensure compliance with relevant regulations and EMS System Policies.

This work supports the County of Monterey Health Department 2025-2028 Strategic Plan Goal 2. Provide Exceptional Person-Centered Care through Accessible, Community-Focused Health

Services. It also supports one of the ten essential public health services, specifically, 7. Link people to needed personal health services and assure the provision of health care when otherwise unavailable.

The Office of the County Counsel has reviewed proposed Amendment No. 8 to the Paramedic Service Provider Agreement as to form.
