WHEREAS, the Monterey County Military and Veterans Services Advisory Commission is honored to recognize **Dr. Gerald D. Griffin** as a 2013 "Veteran of the Year"; and

WHEREAS, Dr. Gerald D. Griffin served in the United States Army from 1965 to 2005; and

WHEREAS, Dr. Gerald D. Griffin retired from the United States Medical Corps in 2005 as a Brigadier General; and

WHEREAS, Dr. Gerald D. Griffin has volunteered his time during various emergencies; fire, flood, hazardous weather, and during times of State and County communications systems failures; and

WHEREAS, Dr. Gerald D. Griffin spends countless hours assisting fire and other emergency responders, donating his time, resources and personal communication equipment; and

WHEREAS, Dr. Gerald D. Griffin has served as the Vice-Chair of the Fort Ord Area Retiree Council and has made valuable contributions towards the preservation of military benefits for Monterey County's retired veterans community; and

WHEREAS, Dr. Gerald D. Griffin has been deeply immersed in the process of delivering the soon to be built VA Clinic on the Former Fort Ord; and

WHEREAS, Dr. Gerald D. Griffin has been active on projects to bring veterans home to the Central Coast, and continues to work with the California Department of Veterans Affairs to keep this work alive and to seek continued resources; and
