RE: Letter of interest for participation in the Community Recidivism Reduction grant

On behalf of the County of Monterey, I wish to express our interest in participating and receiving funding for the Community Recidivism Reduction grant.

We understand that each county award is set by Penal Code Section 1233.10, and that Monterey is eligible to receive a one-time allocation of \$50,000 to distribute to service providers for community recidivism and crime reduction services.

The Board of Supervisors (BOS) took action on its meeting of September 15th to forward this letter of interest, accept funding from the state's Recidivism Reduction Fund, and distribute these funds to service providers as specified in statute.

The local Community Correction Partnership (CCP) has expressed its agreement in collaborating with the BOS to establish minimum requirements, funding criteria, grant award limits and procedures to award funding to providers, within, and in compliance with, statutory regulations.
