

MITCHEL L. WINICK

President, Dean, and CEO, *Monterey College of Law* (2005 to present)

Mitchel L. Winick serves as President, Dean, and CEO of a unique 501(c)3 non-profit California accredited law school system that includes Monterey College of Law, San Luis Obispo College of Law, Kern County College of Law, and Empire College of Law. MCL is one of the first two California Accredited Law Schools (CALS) authorized to offer a hybrid online J.D./M.L.S. degree program and the only CALS authorized to offer a post-graduate LL.M. degree. The MCL law schools provide high quality, part-time, evening law degree programs for traditional and non-traditional students. The law schools are accredited by the Committee of Bar Examiners of the State Bar of California.

As chief executive and academic officer of the law school system, Winick has grown the institution from a single campus in Monterey to four separate campus locations and a rapidly growing hybrid online degree program. Gross revenue for the non-profit organization has grown from \$785,000 in 2005 to more than \$5M projected for the 2025 fiscal year. Student enrollment has similarly grown from 95 students in 2005 to a projected 300 students in 2025. Winick also serves as a member of the law faculty, teaching courses such as: *Introduction to Constitutional Law, Collaborative Courts, Fundamentals of Law, International Law, Comparative Law, and Law Office Management.*
