as **Independent Transportation Network** day in Monterey County..... )

**WHEREAS**, the Area Agency on Aging has identified transportation as a critical need for Seniors in many areas of Monterey County; and

**WHEREAS**, more than seventy million Americans (about 1 in 5) will be over the age of 65 in 15 years, and may start to experience diminished capacity to drive safely; and

**WHEREAS, Independent Transportation Network Monterey County**, the local non-profit for transportation for seniors, is the only agency in Monterey County providing arm-in-arm, door-through-door, 24-7-365 service; and

**WHEREAS, Independent Transportation Network Monterey County** provides a higher quality of life by offering any ride for any purpose within the service area; and

**WHEREAS, Independent Transportation Network Monterey County** currently serves 325 members and has delivered over 25,000 rides in 12 local communities within the greater Monterey and Salinas area; and

**WHEREAS, Independent Transportation Network Monterey County** volunteers have been trained and background checked, and drive at their convenience in their own cars that are insured and inspected, providing rides that are typically less than 20 minutes; and

**WHEREAS, Independent Transportation Network Monterey County** volunteer drivers find it rewarding, meet interesting people while helping others, plus they can earn credits for themselves or a loved one, or receive mileage reimbursement; and

**WEHREAS, Independent Transportation Network Monterey County** also allows seniors to trade in their automobile for **Independent Transportation Network** transportation credits; and

**WHEREAS, Independent Transportation Network Monterey County** services, which may be used for any purpose, are often used to get people to and from medical appointments, personal care appointments, recreational activities, and social occasions; and

**WHEREAS, Independent Transportation Network Monterey County** does not receive any public funding.

**NOW THEREFORE, BE IT RESOLVED**, that the Monterey County Board of Supervisors, on behalf of the County and all its citizens thereof, hereby declares August 5, 2016 as **Independent Transportation Network** day in Monterey County and encourage all of our citizens to recognize **Independent Transportation Network Monterey County** for the significant impact they have made in our community.
