WHEREAS, on March 28 2024, the Budget Committee (BC) provided direction to staff on unfunded project priorities;

WHEREAS, Housing and Community Development (HCD) as part of the appointed Planning Agency per MCC 2.29.010 has found that the CIP conforms to and is consistent with the 2010 Monterey County General Plan, the Local Coastal Program, and 1982 General Plan as applicable, and this finding is scheduled to be presented to the Planning Commission on June 26, 2024;

WHEREAS, on May 28, 2024, the Board of Supervisors conducted a Budget Hearing, including review of unfunded project priorities, and recommended funding for additional capital projects to be added to the FY 2024/25 budget and CIP work plan.

NOW THEREFORE BE IT RESOLVED THAT the Monterey County Board of Supervisors does hereby approve the County of Monterey Capital Improvement Program Five-Year Plan for Fiscal Years 2024/25 through 2028/29.
