## AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF MONTEREY AND DENISE DUFFY & ASSOCIATES, INC.

**THIS AMENDMENT NO. 3** to Professional Services Agreement No. A-15192 between the County of Monterey, a political subdivision of the State of California ("County") and Denise Duffy & Associates, Inc. ("CONTRACTOR"), is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Professional Services Agreement No. A-15192 with the County on April 20, 2021 ("Agreement") to provide biological consulting services to facilitate the County's implementation of the installation-wide multispecies Habitat Management Plan for the former Fort Ord;

**WHEREAS,** the Parties amended the Agreement on May 3, 2022 ("Amendment No. 1") to extend the term of the Agreement one (1) year to June 30, 2023, with no increase to the not to exceed amount of \$616,205;

**WHEREAS**, the Parties amended the Agreement on April 20, 2023 ("Amendment No. 2") to extend the term of the Agreement one (1) year to June 30, 2024, with no increase to the not to exceed amount of \$616,205;

**WHEREAS**, additional time is necessary to allow CONTRACTOR to continue to provide services identified in the Agreement; and

**WHEREAS,** the Parties wish to further amend the Agreement to extend the term for one (1) additional year to June 30, 2025, with no associated dollar amount increase to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 3.

**NOW, THEREFORE,** the parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 3, "Term of Agreement," to read as follows:

The term of this Agreement is from <u>April 20, 2021</u> to <u>June 30, 2025</u>, unless sooner terminated pursuant to the terms of this Agreement.

- 2. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.
- 3. This Amendment No. 3 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
