

**RENEWAL AND AMENDMENT NO. 2  
TO SERVICES AGREEMENT  
BETWEEN JANE FINNEY, CLS MBA, CPHQ, CPPS AND  
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER  
FOR  
ON-SITE AND OFF-SITE PROFESSIONAL CONSULTING SERVICES**

This Renewal and Amendment No. 2 to the Services Agreement ("Agreement") which was effective on November 23, 2020 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Jane Finney, CLS, M.B.A, CPHQ, CPPS ("CONTRACTOR"); **From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:**

**RECITALS**

**WHEREAS**, the Agreement was executed for On-Site and Off-Site Professional Consulting Services with a term November 9, 2020 through November 8, 2021 and a total Agreement amount not to exceed \$150,000; and

**WHEREAS**, COUNTY and CONTRACTOR amended the Agreement on December 07, 2021 to extend it for an additional one (1) year period through November 8, 2022 with a \$25,000 increase for the added services for a total Agreement amount of \$175,000.

**WHEREAS**, COUNTY and CONTRACTOR currently wish to renew and amend the Agreement to extend it for an additional one (1) year period (November 9, 2022 through November 8, 2023) for a revised full agreement term of November 9, 2020 through November 8, 2023 to allow for services to continue with no changes to the scope of work or to the total Agreement amount.

**AGREEMENT**

NOW, THEREFORE, the Parties agree to renew and amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

1. The first sentence of Section 3 /Paragraph titled, "TERM OF AGREEMENT" shall be amended to the following:  
*"The term of this Agreement is from November 9, 2020 through November 8, 2023 unless sooner terminated pursuant to the terms of this Agreement."*
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Renewal and Amendment No. 2, Amendment No. 1 and Agreement and shall continue in full force and effect as set forth in the Agreement.
3. A copy of this Renewal and Amendment No. 2 shall be attached to the Agreement.
4. This Renewal and Amendment No. 2 shall be effective when both parties have signed.
