

**AMENDMENT NO. 1  
TO SERVICES AGREEMENT  
BETWEEN OPEN TEXT, INC. AND  
COUNTY OF MONTEREY, ACTING THROUGH ITS INFORMATION TECHNOLOGY  
DEPARTMENT,  
FOR  
SERVICE AND MAINTENANCE OF RIGHT FAX**

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on July 1, 2016 is entered into by and between the County of Monterey, acting through its Information Technology Department (hereinafter "COUNTY"), and Open Text, Inc. (hereinafter "CONTRACTOR"); (collectively, the County and CONTRACTOR are referred to as the "Parties"), with respect to the following:

**RECITALS**

**WHEREAS**, the Agreement states that CONTRACTOR is to provide maintenance and support of the County's Right Fax system for the term of July 1, 2016 through June 30, 2019, in a total amount not to exceed \$17,802.00; and

**WHEREAS**, on November 14, 2017, COUNTY and CONTRACTOR entered into an agreement providing for an upgrade to the Right Fax system, the FOIP Enable Delivery Channel.

**WHEREAS**, COUNTY and CONTRACTOR currently wish to amend the Agreement to add maintenance and support of the RightFax FOIP Enable Delivery Channel to the Agreement, adding an additional \$2,640 to the final year of the term for a total of \$8,574 for year three, and a new agreement total of \$20,442.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Section IV. (A) of the Transaction Document to the Agreement, titled, "Payment Provisions", shall be amended to state:

***"A. For the services described in this Agreement within the term specified above, the maximum obligation of the County will be \$20,442."***

2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this Amendment No. 1, and shall continue in full force and effect as set forth in the AGREEMENT;
3. A copy of this Amendment No. 1 shall be attached to the original AGREEMENT.
4. This Amendment No. 1 shall be effective upon execution by both Parties.

IN WITNESS WHEREOF, the Parties hereto are in agreement with this Amendment No. 1 on the basis set forth in this document and have executed this Amendment No. 1 on the day and year set forth herein.
