- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Renewal and Amendment Nos.1, 2, 4 and Amendment 3 are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.

- 5. The effective date of this Amendment is July 1, 2014.
