## AMENDMENT NO. 1

To

## 340B Prime Vendor Participation Agreement By and between County of Monterey and Cardinal Health 110, Inc. and Cardinal Health 411, Inc.

This Amendment No. 1 is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as "County", and Cardinal Health 110, Inc. and Cardinal Health 411, Inc., hereinafter referred to as "Contractor".

## RECITALS:

WHEREAS, the County and Contractor have heretofore entered into a 340B Prime Vendor Participation Agreement to provide discounted outpatient pharmaceuticals to be shipped to the Alisal Health Center for a period of March 24, 2011 to June 30, 2013 ("Agreement"); and

WHEREAS, the County and Contractor wish to amend the Agreement to extend the term of the Agreement for two (2) additional years, as specified below.

NOW THEREFORE, the County and Contractor hereby agree to amend the Agreement, as follows:

- 1. The term of the Agreement, section 7, shall be extended for an additional two (2) year period to June 30, 2015 for a new term of March 24, 2011 to June 30, 2015.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 3. A Copy of this Amendment No. 1 shall be attached to the Agreement.
- 4. The effective date of this Amendment No. 1 is July 1, 2013.
