

**AMENDMENT No. 2 TO ELECTRONIC PATIENT CARE REPORTING (ePCR)
AGREEMENT
BETWEEN
COUNTY OF MONTEREY
AND
ESO SOLUTIONS, INC.**

THIS AMENDMENT No. 2 is made to the Electronic Patient Care Reporting (ePCR) Agreement (“AGREEMENT”) by and between ESO Solutions, Inc., hereinafter referred to as “CONTRACTOR,” and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY.”

WHEREAS, on or about March 31, 2017, COUNTY and CONTRACTOR entered into an AGREEMENT for the provision of Electronic Patient Care Reporting (ePCR) solution for all county first responder, transport, hospitals, and communication agencies for a period from March 31, 2017 to March 30,2020; and

WHEREAS, on or about April 2, 2020, pursuant to Section 7.1 of the AGREEMENT, the County and CONTRACTOR executed Amendment No. 1 (“AMENDMENT No. 1”) to extend the term of the AGREEMENT for 2 years, from the period of March 30, 2020 to March 30, 2022; and

WHEREAS, COUNTY and CONTRACTOR wish to amend the AGREEMENT to extend the term of the AGREEMENT for a period of two (2) years to March 30, 2024 and to increase the amount payable to CONTRACTOR for the services to be provided during the extension period;

NOW THEREFORE, COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 7.1 of the AGREEMENT shall be amended by removing “The term of the AGREEMENT shall be from March 31, 2017 through March 30, 2022” and replacing it with “The term of the AGREEMENT shall be from March 31, 2017 through March 30, 2024.”
2. Section 8.1 of the AGREEMENT shall be amended by removing “the maximum obligation of the COUNTY will be \$450,000.00” and replacing it with “the maximum obligation of the COUNTY will be \$703,416.00.”
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT shall continue in full force and effect.
4. A copy of AMENDMENT No. 2 shall be attached to the original AGREEMENT dated March 31, 2017 and shall be incorporated therein as if fully set forth in the AGREEMENT.

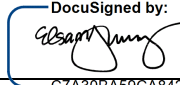
