# BACKGROUND

- Board Referral #2018.22
  - Direction on short and long term plan
- County Campus Master Plan EIR
  - Modular Buildings
    - Temporary
    - Completed removal Fall 2018
- Parking Changes/Needs
  - 111 W Alisal (City/County)
    - Temp Warming Shelter
  - Street Surface Parking (City)
  - Train Station (TAMC)
    - Temporary Juror Parking/Shuttle



# OVERVIEW

- Long Term Plan
  - City Vibrancy Plan
  - County Campus Master Plan
  - Shared Parking Structure
- Short Term Options – Open Space/Parking
  - 4 concept plans
  - Other Options
    - Do nothing (current condition)
- Other Considerations
  - Cost Estimates assume high end
    - Reduce scope = reduce cost (e.g. asphalt vs DG or gravel)
    - More detail of Preferred Option
  - Temporary Use
    - 1-2 years; while assess shared parking structure
      - Timing depends on CEQA, Design & Construction
    - Interim Agreement (City)
    - Remove Temporary Improvements
  - Amend EIR mitigation



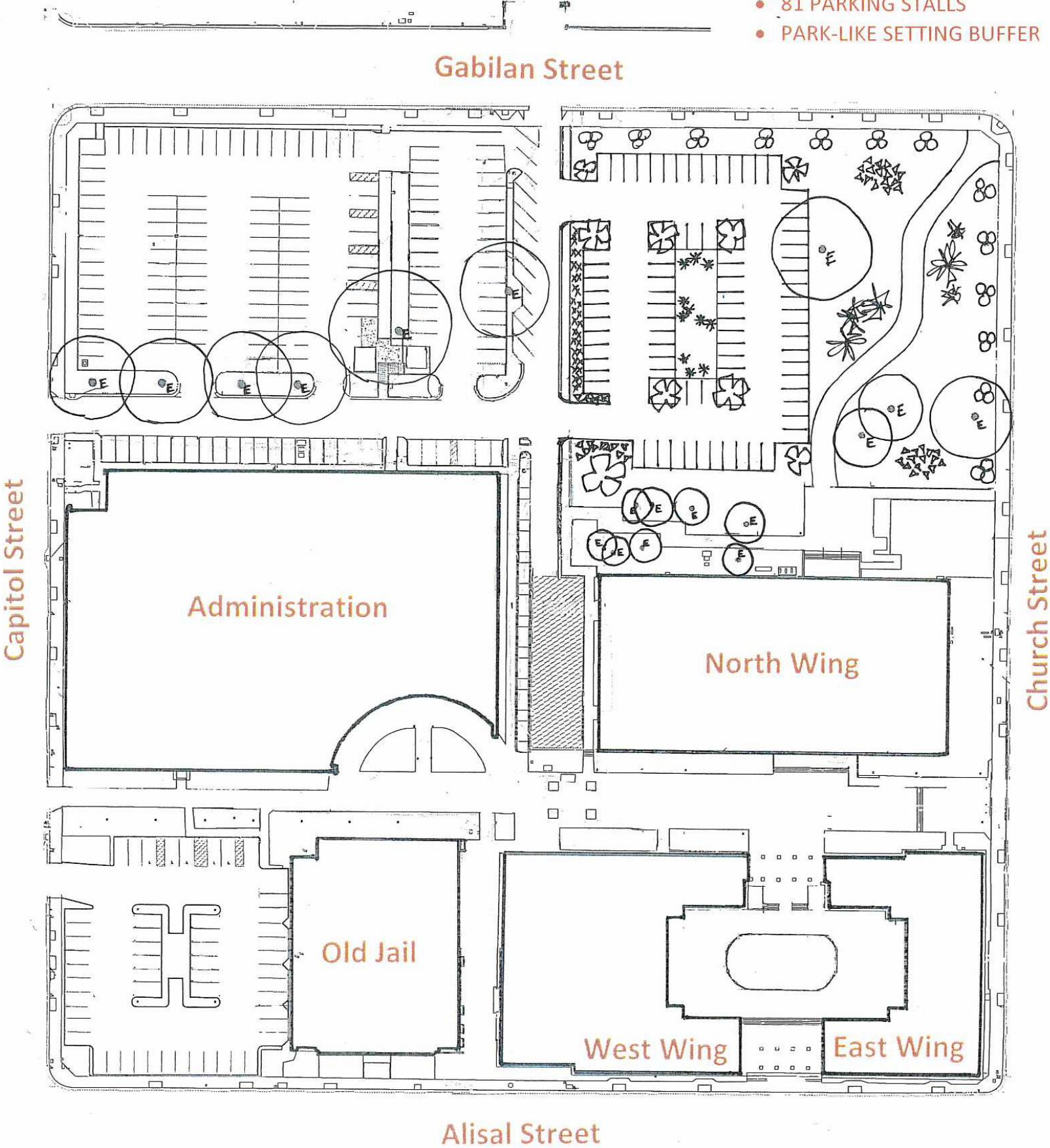
# OPTION 1 – Parking/Open Space

- Gabilan/Church
  - Split Open Space & Parking
- Alisal/Capitol
  - No Change
- Parking
  - 81 new spaces
- Open Space
  - 32,000 sf
  - Irrigated/managed
- Estimated Cost
  - \$2.6M

- 81 PARKING STALLS
- PARK-LIKE SETTING BUFFER



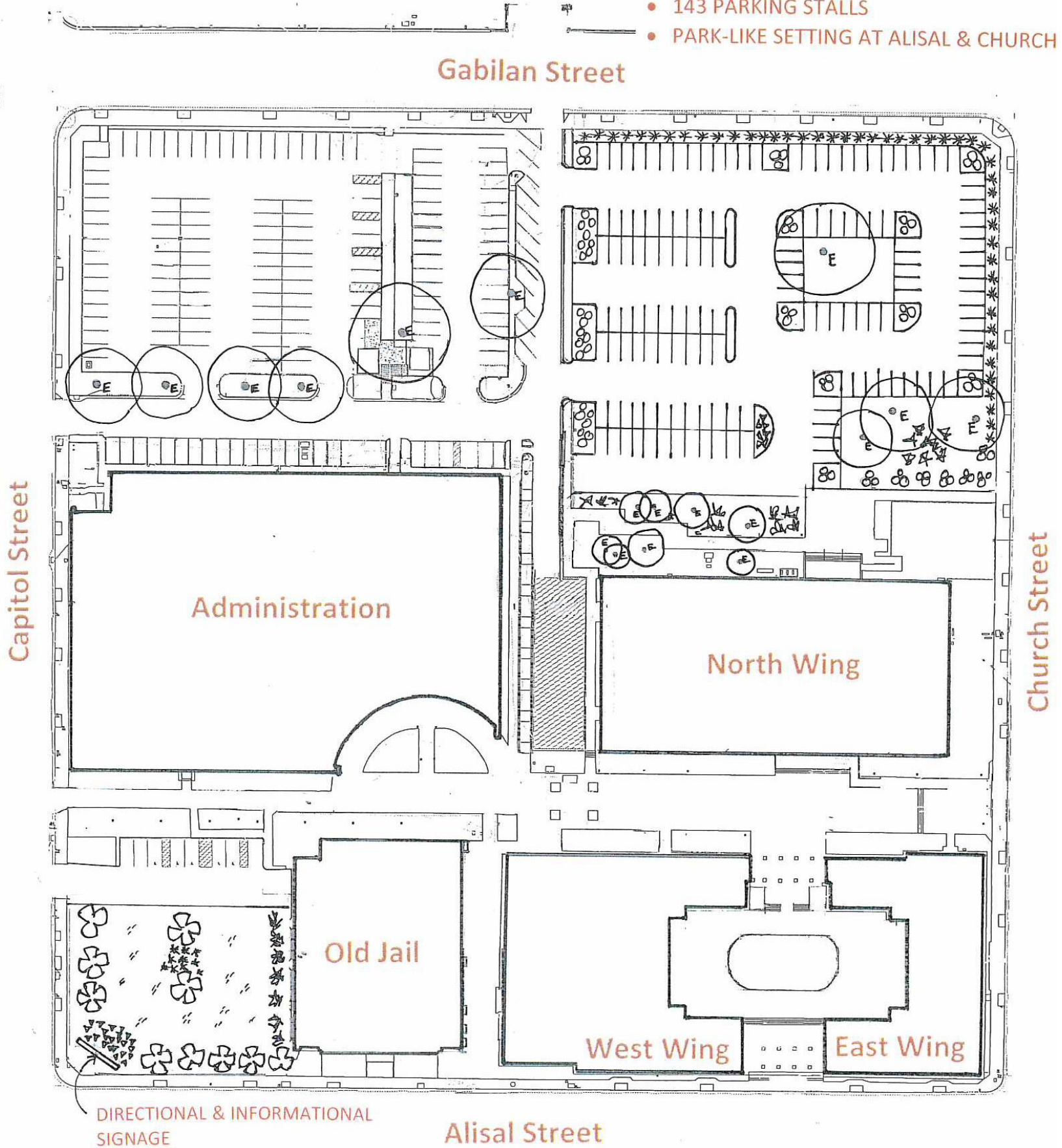
# OPTION 2 - Parking

- Gabilan/Church
  - Maximize Parking
  - Move open space to Alisal
- Alisal/Capitol
  - Replace visitor parking with open space
- Parking
  - 143 new spaces @ Gabilan
  - Remove 47 Spaces @ Alisal (Visitor)
  - Net 96 Added Spaces
- Open Space
  - 15,000 sf @ Alisal
  - Irrigated/managed
- Estimated Cost
  - \$3.7M
- Other Considerations
  - CEQA; Amend EIR
  - Agreement for Temp Use



# OPTION #2

- 143 PARKING STALLS
- PARK-LIKE SETTING AT ALISAL & CHURCH





# OPTION 3 – Open Space

- Gabilan/Church
  - Open Space only
- Alisal/Capitol
  - No Change
- Parking
  - 0 new spaces
- Open Space
  - Adds 64,000 sf
  - Irrigated/managed
- Estimated Cost
  - \$1.95M
- CEQA
  - Fulfills EIR



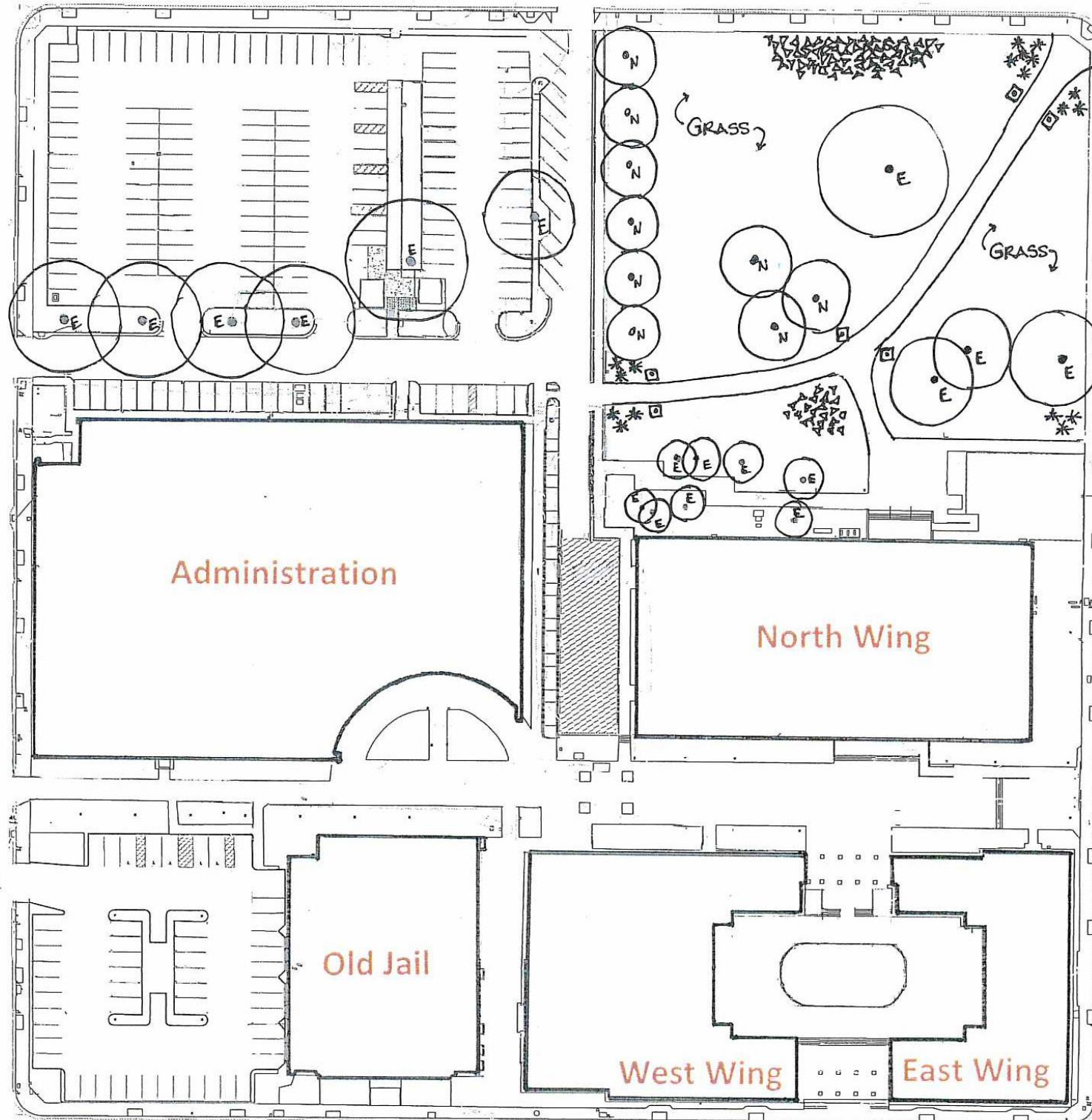

# OPTION 4 – CIC/Parking

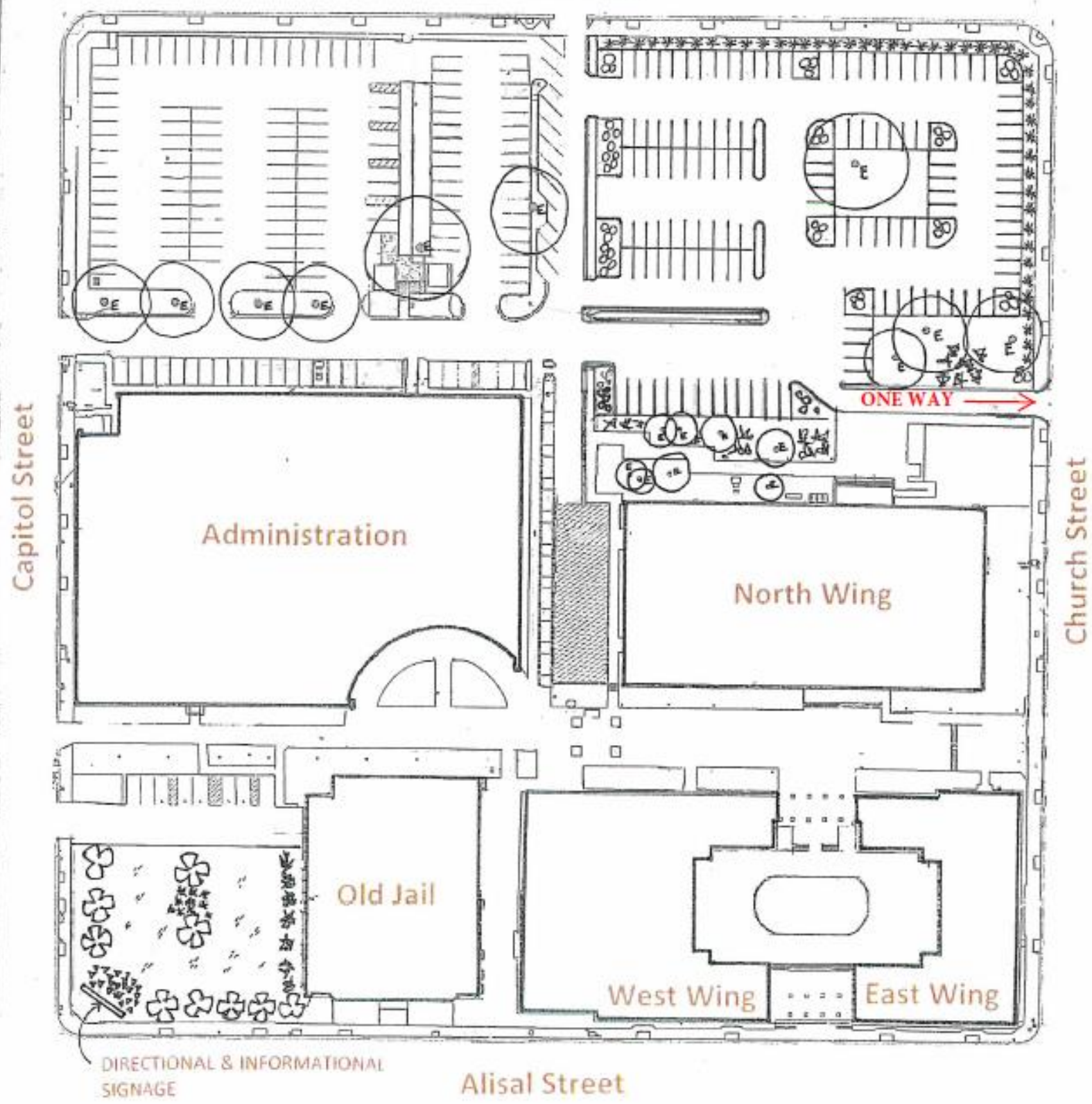
- Gabilan/Church
  - Maximize Parking
  - Corrections Vehicles
  - Move Open Space to Alisal
- Alisal/Capitol
  - Replace visitor parking with open space
- Parking
  - 132 new spaces @ Gabilan
  - Remove 47 Spaces @ Alisal (Visitor)
  - Net 85 Added Spaces
- Open Space
  - 15,000 sf @ Alisal
  - Irrigated/managed
- Estimated Cost
  - \$3.75M
- Other Considerations
  - CEQA; Amend EIR
  - Agreement for Temp Use
  - Church St. Encroachment (City)

      - Retain Visitor Parking @ Alisal (net 132 new spaces)?
      - Asphalt vs DG/Gravel?
  - Environmental Assessment
    - Concept Plans (Short Term, Long Term)
  - Refine plan and cost estimate (Preferred Option)
  - Work with Budget Office for funding (FY18/19 vs FY19/20)
    - Return to CIC, BC and BOS as needed
