WHEREAS, James Bogart was duly initiated into The Kappa Sigma Fraternity by the Delta-Eta Chapter in September of 1970; and

WHEREAS, James Bogart received the Degree of Juris Doctor from the University of the Pacific McGeorge School of Law in Sacramento, California on May 28, 1977; and

WHEREAS, James Bogart was inducted as a member of The Traynor Society Scholastic Honor Organization on May 28, 1977; and

WHEREAS, James Bogart was admitted as an Attorney and Counselor at Law and took the oath from the Supreme Court of the State of California on June 23, 1978; and
