## Attachment A – Vocational Training & Education

- 1. <u>Agreement #1 with Rancho Cielo</u> to provide vocational training, paid work experience, and employment support services to youth under Probation juvenile jurisdiction ages 16-24 at the Rancho Cielo Youth Campus; term 12/10/2024 6/30/2025. NTE \$76,369. (JJCPA)
- 2. Agreement #2 with Rancho Cielo to provide job readiness and placement program (Rancho Cielo Youth Corps) to all clients referred by the Probation Department and identified as AB109 or SB823 funded participants ages 18-25; term 7/1/2024 6/30/2025; NTE \$181,166.

## 3. PEP – Prison Education Program

The Prison Education Program continues to provide expanded education opportunities for the detained populations in Monterey County, as well as multiple adult and juvenile facilities throughout California. With the assistance of university students and faculty, PEP has serviced over 8,000 in-custody students since 2011. PEP is the largest volunteer-based education program of its kind in the United States. PEP provides academic, life skills, and career development programming, aiming to educate, empower, and transform the lives of detained individuals. In Monterey County, PEP has provided: Introduction to Psychology; Auto Biographical Writing; Introduction to Film, U.S. Government, Theatre, Philosophy, Financial Literacy, Mathematics, and Music Appreciation. These courses are intended to prepare students for post-graduate education courses and future career pathways.

## 4. Hartnell College Rising Scholars Program

Hartnell College Office of Equity provides credible messengers/student mentors to assist youth in developing educational skills, supports and resources, and weekly office hours on site for tutoring and educational planning. Currently there are (3) in-person classes that are facilitated on site and an additional asynchronous class that our students access on computers, utilizing the Hartnell Canvas platform.

## 5. Pine Grove Conservation Camp

Probation Department has contracted with the State of California, Department of Corrections and Rehabilitation, Youth Fire Camp to allow youth committed to the Secure Youth Treatment Program (SYTF) by the Juvenile Court to be voluntarily placed in the program for CAL FIRE certified training for wildland firefighting operations and the potential for employment as a firefighter upon release.

- 6. Paxton Patterson Program College and Career Ready Labs
  - The ultimate career exploration to engage students in authentic problem-based learning experiences as they discover their interests and aptitudes. This is a program with exposure to a broad range of Career Clusters, or define a more focused pathway like STEM, College & Career Ready Labs provide a model for success. (in place at Youth Center, pending JH)
- 7. <u>Toyota Materials Handling Fork Lift Training Program</u> SYTF youth have been enrolled and participated in.
- 8. <u>Food Handling (FH)Permit Certification Program at Youth Center (taught by Cook and staff) Many in-custody youth have obtained their FH Permits.</u>
- 9. Gladeo System MCOE

This career exploration program/software is currently being set up and established at the YC and JH. Gladeo Monterey County offers a personal career exploration experience with features like a career quiz, detailed job profiles, pathway opportunities, and inspiring stories and videos. Students can also connect with local educational and industry resources, gaining insight into high-growth and in-demand careers. This platform is part of MCOE's and the County Board's commitment to bridging career exploration gaps and providing access to every student in Monterey County.
