WHERAS, Margaret Ann Cuisinier began her public service in May 1973 as a Clerk Typist I, and held the subsequent titles of Clerk Typist II and III, Eligibility Worker I, II, and III, Eligibility and CalWORKs Employment Services Supervisor, CalWORKs Employment Services Assistant Program Manager, CalWORKs Employment Services Administrative Services Officer, and CalWORKs Employment Services Management Analyst II; and

WHEREAS, Margaret Ann Cuisinier, during her tenure in eligibility, was recognized as the Monterey County Refugee Program expert and for her leadership of implementing the Refugee Demonstration Project, and as an Eligibility Supervisor, she was recognized for completing the best employee performance evaluations, and as a result was assigned to develop and provide *Evaluation Content and Performance Standards* training to all new Eligibility Supervisors; and

WHEREAS, Margaret Ann Cuisinier made significant contributions to programs that changed customer's lives, such as, Pueblo Del Mar, Family Stabilization, Family Reunification and the Cal-Learn Program by helping plan, develop, and implement the programs; and

WHEREAS, Margaret Ann Cuisinier, provided major support and participated on every automation project for Eligibility and Greater Avenues of Independence-CalWORKs Employment Services, and helped with the successful implementation of the Greater Avenues of Independence On-Line System, Interim Statewide Automated Welfare System and Interim Statewide Automated Welfare System Welfare-to-Work, and was the co-lead of the Change Management Team in converting from Welfare-to-Work to Consortium IV, and she was instrumental in developing E-2 Lite Access Database to track the county's federal work participation rate; and
