



as of November 29, 2020




Rolling 7-Day Daily Rate per 100,000




#### **COVID-19 Among Monterey County Residents**

as of November 29, 2020




### Monterey County Hospitalization Census: Confirmed COVID-19 Patients

as of November 29, 2020









# Region of Residence Among Monterey County COVID-19 Cases as of November 28, 2020



# Age Distribution Among Monterey County COVID-19 Cases as of November 28, 2020










## Self-Reported Industry Sector Among Monterey County COVID-19 Cases as of November 28, 2020






#### CDPH Blueprint for a Safer Economy Metrics Monterey County Adjusted Case Rate

## Strategies to Reduce Transmission

### Promote Behavior Modification

- Limit gatherings
- Delay travel
- Wear face coverings
- Practice social distancing
- Support businesses' efforts to implement CDPH guidance

### Increase Testing Opportunities

- Focus on areas with highest positivity rates and lowest testing rates
- Add pop-up testing sites
- Expand CDPHsponsored sites
- Facilitate distribution of rapid antigen test kits
- Expand public health lab testing capacity

### Encourage Isolation & Quarantine

- Continue case investigation & contact tracing
- Work with medical providers to emphasize isolation at the time of testing
- Partner with communityorganizations for isolation stipend program
- Provide alternative housing

### Plan for Vaccine Distribution

- Survey medical providers, skilled nursing facilities, and other priority groups
- Use flu vaccine clinics as COVID-19 vaccine preparedness exercises
- Secure additional equipment & supplies



# COVID-19 Vaccine



### COVID-19 Vaccine

- Influenza vaccine clinics serve as COVID-19 vaccine preparedness drills.
- ➤ Hospitals and clinics encouraged to register with CDPH to receive disbursements of COVID-19 vaccine.
- Engaged with hospitals, skilled nursing facilities, clinics, and first responders to prepare for COVID-19 vaccine receipt, storage and administration.
- ➤ All SNF signed up for pharmacy vaccine program.
- ➤ Ordered one ultra low temperature freezer for Public Health and three for Clinic Services
- Entering contracts for dry ice supply.

# Federal ACIP COVID-19 Vaccines Work Group

ACIP Proposed Interim Phase 1 Sequence, November 23

#### Phase 1a

- Health care personnel
- Long term care facility residents

#### Phase 1b

Essential workers

#### Phase 1c

- Adults with hi-risk medical conditions
- Adults 65 years of age and older

ACIP is voting now on Phase Sequence Recommendation



# California Community Vaccine Advisory Committee Recommendations

COVID-19 vaccine should be offered to the following persons during Phase 1a

- Persons at risk of exposure to SARS-CoV-2 through their work in any role in direct health care or long-term care settings (including non-clinical roles).
  - 2 million Californians, needed to sustain health services

# California Community Vaccine Advisory Committee Recommendations

COVID-19 vaccine should be offered to the following persons during Phase 1a

- If recommended by the federal Advisory Committee on Immunization Practices (ACIP) for inclusion in Phase 1a, residents of skilled nursing facilities, assisted living facilities, and similar settings for older or medically vulnerable individuals.
  - 300,000 400,000 Californians, representing 1% of population, 6% of COVID-19 cases, and 34% of deaths

# Federal Pharmacy Partnership for Long Term Care Facility Vaccination

- CVS and Walgreens have contracted to vaccinate both long term care staff and residents.
- Three separate visits to each facility
- •As of November 30, 2020, 99% of SNF have signed up for the program.
