WHEREAS, the State of California currently uses three automated welfare systems and is migrating all 58 counties to the California Statewide Automated Welfare System (CalSAWS) by 2023; and

WHEREAS, the CalSAWS Migration requires knowledgeable experts from the counties to assist in the planning, development and execution of the conversion across all 58 counties; and

WHEREAS, the CalSAWS Migration Project held a competitive recruitment process and one (1) Business Technology Analyst II from Monterey County was chosen to work on the statewide project for approximately 36 months until implementation in 2023; and

WHEREAS, the BTA II chosen for the project will remain a county employee and will be located full-time at the CalSAWS Migration Project site in Rancho Cordova, CA, with all salary, benefits, travel and per diem fully reimbursed by the CalSAWS Migration Project; and

WHEREAS, the Department of Social Services has determined the need to add one (1) Business Technology Analyst II (BTA II) to backfill behind the current position so that the Department can continue to meet the service needs of a large department; and

WHEREAS, the Department will require an increase in FY 2019-20 appropriations and revenues of \$70,764 which will be fully reimbursed by the CalSAWS Migration Project.

NOW, THEREFORE, BE IT RESOLVED THAT, the Monterey County Board of Supervisors does hereby:

a. Amend the Department of Social Services Budget Unit 001-5010-8262-SOC005 to add one (1) Business Technology Analyst II as indicated below:
