

**AMENDMENT NO. 2
TO SERVICE AGREEMENT A-13133
BETWEEN COUNTY OF MONTEREY AND
RANCHO CIELO, INC.**

This Amendment No. 2 to Service Agreement A-13133 is made and entered into by and between the **County of Monterey**, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and **Rancho Cielo, Inc.** (hereinafter referred to as RANCHO CIELO).

WHEREAS, the COUNTY entered into a Service Agreement A-13133 with RANCHO CIELO to allow the Monterey County Health Department, Behavioral Health Bureau to provide psychiatric services at the Rancho Cielo Youth Campus (no exchange of funds) for term of July 1, 2016 to June 30, 2017; and

WHEREAS, the COUNTY entered into an Amendment No. 1 to the Service Agreement A-13133 with RANCHO CIELO to extend the term date for one year to allow the Monterey County Health Department, Behavioral Health Bureau to provide psychiatric services at the Rancho Cielo Youth Campus (no exchange of funds) for term of July 1, 2016 to June 30, 2018; and

WHEREAS, the COUNTY and RANCHO CIELO hereby request Amendment No. 2 to amend the Service Agreement A-13133 as follows:

- Extend the term date of the Agreement to June 30, 2019 for a new term date of July 1, 2016 to June 30, 2019.

NOW THEREFORE, the COUNTY and RANCHO CIELO hereby agree to amend this Service Agreement A-13133 as follows:

1. Front Page of the Service Agreement is amended to read as follows: "July 1, 2016 through June 30, 2019."
2. Section VII. 'General Provisions, Item A. **Period of Performance**' of the Service Agreement is amended to read as follows: "Subject to other Agreement provisions, the period of performance under this Agreement is effective July 1, 2016 through June 30, 2019."
3. Except as provided herein, all remaining terms, conditions and provisions of this Service Agreement are unchanged and unaffected by this Amendment No. 2, and shall remain in full force and effect.
4. This Amendment No. 2 shall be effective July 1, 2018.
5. A copy of this Amendment No. 2 shall be attached to the original Service Agreement A-13133.
