WHEREAS, Karen Csejtey recently retired after 15 years as Executive Director of Leadership Monterey Peninsula, a nonprofit community leadership training organization providing programs for individuals who want to make a positive impact in their community; and

WHEREAS, Karen Csejtey came to Leadership Monterey Peninsula from Family Service Agency of Monterey County where as Development Director she assisted in the transition of a newly merged organization by creating a Fund Development Department and managing and coordinating a variety of fundraising activities in support of prevention and intervention programs for families; and

WHEREAS, Karen Csejtey has over 30 years' experience in the nonprofit sector and small business enterprises having owned and operated two businesses and co-founded three nonprofit organizations where, at various times, she served as executive director, board member, program director, and volunteer; and

WHEREAS, for the last 25 years, Karen Csejtey has maintained an organizational development training and consulting practice with training topics that include: teambuilding, communication, meeting facilitation, problem-solving, decision-making, community leadership, strategic planning, conflict resolution, board and staff development, mediation, fundraising, organizational assessment, marketing, and business plan development; and

WHEREAS, Karen Csejtey was the executive director of Touchstone Support Network dedicated to providing support services for children with life-threatening illnesses and their families; and

WHEREAS, Karen Csejtey directed the Women Entrepreneurs Program on the San Francisco Peninsula providing a variety of services to train and support women (and a few good men) in successfully starting and running their own businesses with services that included business classes, individual counseling, support groups, a revolving loan fund, conferences and forums to train and support women in successfully starting and running their own businesses; and

WHEREAS, Karen Csejtey was a founding board member of the statewide trade organization, the California Association of Micro-enterprise Opportunity; and

WHEREAS, Karen Csejtey has a BS degree in Organizational Development from the University of San Francisco, a Certificate in Training and Human Relations from UC Santa Cruz, and extensive additional training in business development and management, community leadership, project management, mediation, fundraising, and nonprofit administration; and

WHEREAS, Karen Csejtey is a recipient of the Jefferson Award from the American Institute for Public Service in Washington, DC; the "For Those Who Care" Community Service Award from KRON TV in San Francisco; and the Athena Award from the Palo Alto Chamber of Commerce; and

WHEREAS, Karen Csejtey is currently serving as the Interim Executive Director of Papillon Center for Loss and Transition and continues to provide consulting services to local nonprofit organizations.
