She would also like to see a program that is addressing the short term rental ordinance that recognizes that the County is working on creating more housing units rather than taking them away due to short term rentals in District 5 in particular and likes the programs being currently recommended.

Secretary Quenga informed the Commission of the workshop on the Housing Element Update going to Board of Supervisors on June 11, 2024. Mr. Spencer also updated the Commission on the Riverview item that went to Board of Supervisors on June 4, 2024.
