WHEREAS, Section 7910 of the Government Code, which became effective on January 1, 1981, requires the governing body of each local jurisdiction to establish by Resolution its appropriation limit for the following fiscal year pursuant to Article XIII B of the California State Constitution at a regularly scheduled or noticed meeting; and,

WHEREAS, the Office of the Auditor-Controller has calculated the proper appropriations limit for fiscal year 2017-2018 to be Six Hundred Fifty-two Million, Twelve Thousand, Two Hundred Thirteen Dollars (\$652,012,213); and

WHEREAS, at least fifteen (15) days prior to this date, documentation used in the determination of the appropriation limit was available to the public in the Office of the Auditor-Controller;
