**WHEREAS, Chief Deputy Jerry D. Teeter** began his law enforcement career with the Monterey County Sheriff’s Office in 1984; and

**WHEREAS, Chief Deputy Jerry D. Teeter** was born in 1961 and was raised in Firebaugh, CA. where he graduated from Firebaugh-Las Deltas Joint Unified High School and after graduating from California State University-Fresno in 1983 was sworn in as a Reserve Deputy with the Fresno County Sheriff’s Office; and

**WHEREAS, Chief Deputy Jerry D. Teeter** came to the Monterey County Sheriff’s Office after a year of serving as a reserve deputy and subsequently attending the Central Coast Counties Police Academy at Gavilan College; and

**WHEREAS, Chief Deputy Jerry D. Teeter** was sworn in on June 25, 1984 by Administrative Bureau Chief Don Ennis and over his career, has served for six Monterey County Sheriffs; D.B. “Bud” Cook, Norm Hicks, Gordon Sonn , Mike Kanalakis, Scott K. Miller and Steve Bernal; and

**WHEREAS, Chief Deputy Jerry D. Teeter** has served as a Patrol Deputy, Patrol Field Training Officer, Patrol Sergeant, FTO Sergeant, Internal Affairs Sergeant, Special Operations Division Commander, Homeland Security Division Commander, Investigations Division Commander, Coroner’s Division Commander, Patrol Commander and Chief Deputy of the Enforcement Operations Bureau and has also held various collateral assignments including: SWAT Team Member, SWAT Team Sergeant, Tactical Unit Squad Leader; and

**WHEREAS, Chief Deputy Jerry D. Teeter** was a member of the Monterey County Sheriff’s Office Memorial Committee; and

**WHEREAS, Chief Deputy Jerry D. Teeter** was promoted to Chief Deputy on March 5, 2015 and retires as a Chief Deputy assigned to the Enforcement Operations Bureau; and

**WHEREAS, Chief Deputy Jerry D. Teeter** received a Meritorious Service Award in June 1994 for his outstanding effort and work performance as a member of the Investigations Division; and

**WHEREAS, Chief Deputy Jerry D. Teeter** was awarded Deputy of the Month in March 1989 by the Deputies Benefit Association for his actions at the scene of a multi-injury/fatal vehicle accident in Arroyo Seco and in June 1990 for his actions during a large gang fight in King City; and
