**WHEREAS, Star Howard** has served the people of Monterey County for forty years, having been hired on September 14, 1984, in the Community Benefits Branch as an Eligibility Worker I in the King City Office, promoted to Eligibility Worker III in 1989 in the Salinas Office, then promoted to Eligibility Supervisor; From there **Star Howard** promoted to the position of Management Analyst II and III, and then promoted to Program Manager II in 2010, all in the Community Benefits Branch of the Department of Social Services; and

**WHEREAS, Star Howard** also served as the Interim Deputy Director of Community Benefits Branch on July 6 2019 through August 2, 2019, and August 31, 2019 through September 27, 2019, and

**WHEREAS, Star Howard** was key in developing our Same Day Service process for our Intake Operations which expedited benefits for all public assistance programs, and

**WHEREAS, Star Howard** co-coordinated with the Adults Services Branch to launch our departments Supplemental Security Income (SSI) Advocacy Program, generating reimbursements to our county, and

**WHEREAS, Star Howard** was selected as the Community Benefits Mobile Team Supervisor, and

**WHEREAS, Star Howard** was the first MC-CHOICE Outreach Coordinator, as such she lead this team in expanding outreach services throughout our county, and the program was awarded the National Hunger Champions Award for our innovative outreach program.
