

**AMENDMENT NO. 2  
TO PROFESSIONAL SERVICES AGREEMENT  
BETWEEN COUNTY OF MONTEREY AND  
TRC ENGINEERS, INC.**

**THIS AMENDMENT NO. 2** to the Professional Services Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and TRC Engineers, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the County and CONTRACTOR are referred to as the "Parties").

**WHEREAS**, CONTRACTOR entered into a Professional Services Agreement with County on December 28, 2010, (hereinafter, "Agreement"); and

**WHEREAS**, Agreement was amended by the Parties on February 1, 2012 (hereinafter, "Amendment No. 1"); and

**WHEREAS**, Task 1.A, Project Startup and Survey Coordination, Task 1.D, Pathway Planning Studies, Task 1.G, Feasibility Report, Task 1.I, Environmental, Task 1.J, Phase 1 Initial Site Assessment, Task 1.P, Visual Impact Assessment, and Task 1.Q, Move Alignment in Caltrans Right-of-Way, for the Castroville Railroad Crossing Bicycle/Pedestrian Path (hereinafter, "Project") have been completed; and

**WHEREAS**, due to the delay caused by negotiations with Caltrans for the re-alignment of the Project into the Caltrans right-of-way, additional time is necessary to complete the remaining tasks related to the Project; and

**WHEREAS**, the Parties wish to further amend the Agreement to extend the term to December 28, 2013 with no associated dollar amount increase to allow CONTRACTOR to continue to provide tasks identified in the Agreement.

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:  
  
The term of this Agreement is from December 28, 2010 to December 28, 2013, unless sooner terminated pursuant to the terms of this Agreement.
2. The Project Schedule referenced in Amendment No. 1, Exhibit A-1 – Scope of Services/Payment Provisions, is hereby amended to extend through December 28, 2013, to conform to the amended term of the Agreement.
3. All other terms and conditions of the Agreement remain unchanged and in full force.

4. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.


