Honoring Floyd Owens

Upon his Selection as the 2012 King City Chamber of Commerce and Agriculture Citizen of the Year

WHEREAS, *Floyd Owens* was born in Brookings, South Dakota, he arrived to El Centro, California with his mother and stepfather at age eight and earned a wage by having the largest paper route in the City; and

WHEREAS, *Floyd Owens* was greatly involved with the Boy Scouts; he earned an Eagle Scout Badge at age fifteen, and in 1963 graduated from high school and took a job driving trucks for one of his neighbors, Gene Lundy; and

WHEREAS, *Floyd Owens* was adopted by the Lundy family, shortly thereafter he came to the City of King and met his wife, Lyn Merril; and

WHEREAS, *Floyd Owens* drove carrot trucks upon his arrival to the City of King, he later began working for Standard Station when the produce work ran out and has been affiliated with Standard Oil since; and

WHEREAS, *Floyd Owens* employed many college students during his tenure as Assistant Manager at Standard Oil on Third and Broadway Streets, in 2014 will mark his fiftieth year associated with Standard Oil; and

WHEREAS, *Floyd Owens*' father in law asked him if he was interested in joining the local Volunteer Fire Department, Floyd accepted and worked his way up the ladder from manning the hose, to engineer, to Assistant Chief, to Chief in 1975; and

WHEREAS, *Floyd Owens* during his tenure as Chief took classes at Hartnell with the State Fire Marshall to educate himself on the regulations and rules pertaining to fire protection, he served as the Deputy State Fire Marshall from 1976 to 1979 where he took the Fire Department from one of modest training to an organized fire department with scheduled meetings and trainings; and

WHEREAS, *Floyd Owens* helped the City build a new fire house, acquired two new fire engines and established training procedures that could be followed for years to come, his greatest success came when the City of King was notified that the fire rating for the City was reduced from a protection class seven to a five, which is a very rare occurrence for an all volunteer fire department, and translated into big savings on fire insurance premiums; and

WHEREAS, *Floyd Owens* was chosen by his peers in 1985 as King City Fireman of the Year and retired in 2000 after thirty-five years of service, it is difficult to measure the savings to the City of King in dollars, but it is easy to say that during Floyd's leadership the city saved millions of dollars; and

WHEREAS, *Floyd Owens* contribution doesn't end with the Fire Department, he was a member of the King City Jaycees, King City Rotary, Masonic Lodge # 302, King City Young Farmers, and the Century Club for Boy Scouts, he is a long time member and past president of the King City Men's Golf Club; and
