## AMENDMENT NO. 1 TO AGREEMENT No. A-11777 BETWEEN THE COUNTY OF MONTEREY AND BSK ANALYTICAL LABORTORIES

WHEREAS, BSK Analytical Laboratories, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY" previously entered into Agreement No. A-11777, hereinafter referred to as "Agreement", dated July 1, 2010, for the provision of Environmental Laboratory Testing & Analysis services, for the period of July 1, 2010 through June 30, 2013 in the amount of \$300,000; and

WHEREAS, the Agreement will expire on June 30, 2013; and

WHEREAS, COUNTY and CONTRACTOR wish to: a) extend the term of the Agreement for three additional years through June 2016; and b) increase funding by an additional \$200,000, for a revised total amount not to exceed \$500,000.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Amend #2. "Payments by County", second sentence to read as follows: The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$500,000.
- 2. Amend #3, "Term of Agreement", first sentence to read as follows: The term of this Agreement is from July 1, 2010 to June 30, 2016.
- 3. All other terms and conditions of the Agreement remain unchanged and in full force.
- 4. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
