

**AMENDMENT #1 TO AGREEMENT  
COUNTY OF MONTEREY AND  
SAN FRANCISCO REGION OF THE SPORTS CAR  
CLUB OF AMERICA**

**THIS AMENDMENT #1** is made to the AGREEMENT (Agreement ID: 5/1/2020-12/31/2022) for the provision of race support services to WeatherTech Raceway Laguna Seca at specific events in the **County of Monterey Standard Agreement** by and between **SAN FRANCISCO REGION OF THE SPORTS CAR CLUB OF AMERICA**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”; and

**WHEREAS**, the County executed the original AGREEMENT on May 1, 2020; and

**WHEREAS**, the County and CONTRACTOR wish to amend the AGREEMENT to reflect an amendment to Exhibit A “Scope of Services” to the County of Monterey Standard Agreement San Francisco Region of the Sports Car Club of America (SCCA).

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Exhibit A, Section 1.4.1.1 shall be deleted in its entirety and replaced with the following:

Driver Appreciation Weekend: August 8 - 9, 2020

- Full Race Support Services

2. Exhibit-A, Section A1.4.1.2 shall be deleted in its entirety and replaced with the following:

Ferrari Challenge Series: September 23 - 27, 2020

- CONTRACTOR shall provide Emergency Vehicle Services for five (5) days at \$4,000 per day.

3. Exhibit A, Section A1.4.1.3 shall be revised as follows:

IMSA Monterey SportsCar Championship: October 30 – November 1, 2020

4. Exhibit A, Section A1.4.1.4 shall be deleted in its entirety.

5. Exhibit A, Section A1.5.1.1 shall be revised as follows:

Based on the Total Retail Value of \$176,000 for SCCA Track Days, less the total Event Support Costs for 2020 Event Dates serviced by CONTRACTOR of \$130,000, there is a balance of \$46,000 owed by CONTRACTOR to County.

7. Addition of Exhibit A, Section 1.3.10 shall be added to state “the COUNTY is not responsible for providing power along Z Road for CONTRACTOR and may charge where COUNTY deems necessary.”
8. A copy of the AMENDMENT #1 shall be attached to the original AGREEMENT signed May 27, 2020.
