WHEREAS, NMC recommends that 4.0 FTE Radiologic Technologist, 1.0 FTE Supervising Nurse I, 1.8 FTE Staff Nurse II, and 1.8 FTE Surgical Technician positions be added to the Natividad Medical Center Fiscal Year 2014-15 Budget (Unit 9600) in order to meet the demands for additional staff; and
