

**AMENDMENT NO. 8
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN Hydrex Pest Control AND
THE NATIVIDAD MEDICAL CENTER
FOR
Pest Control Services**

This Amendment No. 8 to Professional Services Agreement ("Agreement"), dated July 1, 2006, is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Hydrex Pest Control (Contractor), with respect to the following:

RECITALS

WHEREAS, the County and Contractor amended the Agreement previously on July 1, 2007 via Renewal and Amendment No. 1, on July 1, 2008 via Renewal and Amendment No. 2, on July 1, 2009 via Renewal and Amendment No. 3, on July 1, 2010 via Renewal and Amendment No. 4, on July 1, 2011 via Renewal No. 5 on July 1, 2012 via Renewal and Amendment No. 6 on July 1, 2012 and via Renewal and Amendment No. 7 on July 1, 2013; and

WHEREAS, the County and Contractor wish to amend the Agreement to increase the amount of the Agreement by \$14,000 to extend the term end date to allow for existing services to continue.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Contractor will continue to provide NMC with the same scope of services as stated in the original Agreement No. (A-12557/MYA704).
2. Section 2. "PAYMENTS BY NMC" shall be amended by removing, "*The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$109,000.00.*" and replacing it with "*The total amount payable by County to CONTRACTOR under Agreement No. (A-12557/MYA704) shall not exceed the total sum of \$123,000.00 for the full term of the Agreement*".
3. Section 3. "TERM OF AGREEMENT" shall be amended by removing, "*The term of this Agreement is from July 1, 2006 to June 30, 2014 unless sooner terminated pursuant to this Agreement*" and replacing it with "*The term of this Agreement is from July 1, 2006 to June 30, 2015 unless sooner terminated pursuant to this Agreement*".
4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Renewal and Amendment Nos. 1, 2, 3, 4, 5, 6, and 7 ~~Renewal~~ are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.
5. A copy of this Amendment No. 8 and all previous amendments shall be attached to the original Agreement No. (A-12557/MYA704).
6. The effective date of this Amendment is July 1, 2014.






