AMENDMENT NO. 2 TO THE STANDARD AGREEMENT BETWEEN COUNTY OF MONTEREY AND NORCAL RENTAL GROUP LLC dba CRESCO EQUIPMENT RENTALS

THIS AMENDMENT NO. 2 (Amendment) is made to the Standard Agreement between the County of Monterey, a political subdivision of the State of California ("County") and Norcal Rental Group LLC dba Cresco Equipment Rentals (hereinafter, "Contractor") (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, the Parties entered into a Standard Agreement on April 17, 2023 (the "Agreement") to allow Contractor to provide golf cart rentals and services (the "Services"); and

WHEREAS, the County and Contractor executed Amendment No. 1 to the Agreement on January 9, 2024 to extend the term of the Agreement, amend Exhibit A, and increase the not to exceed sum; and

WHEREAS, the Parties wish to further amend the Agreement to increase the not to exceed sum; and

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Section 2, "Payment Provisions" is deleted in its entirety and replaced with: "County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$400,000".
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
- 3. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
