WHEREAS, Public Health Laboratory provides support of public and community health efforts including testing for COVID-19; and

WHEREAS, the Public Health Microbiologist classifications are critical to the operations of the Public Health Lab at the County of Monterey; and

WHEREAS, a wage study for the classification of Public Health Microbiologist II was conducted and identified the currently salary is 9.09% below the survey mean; and

WHEREAS, the Human Resources Department recommends the salary of the Public Health Microbiologist II classification be adjusted to match the survey mean; and

WHEREAS, the Human Resources Department recommends the salary ranges of the Public Health Microbiologist I and the Senior Public Health Microbiologist also be adjusted by 9.09% in order to maintain the salary differential between the classification series.

NOW, THEREFORE, the Monterey County Board of Supervisors, effective August 15, 2020, hereby resolved to approve the following:

1. The Personnel Policies and Practices Resolution (PPPR) No. 98-394 Appendix A is amended to adjust the Salary Ranges for the Classifications of Public Health Microbiologist I; Public Health Microbiologist II; and Senior Public Health Microbiologist; as indicated below;
