

**RENEWAL AND AMENDMENT NO. 2
TO AGREEMENT BY AND BETWEEN
County of Monterey and CaptureRX**

THIS RENEWAL AND AMENDMENT NO. 2 to the Agreement is made by and between **CaptureRX** hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as “County”.

WHEREAS, on December 1, 2019, the COUNTY and CONTRACTOR have heretofore entered into an Agreement for 340B pharmacy claims identification and reporting services for the term December 1, 2019 through December 31, 2021 and an amount of \$25,000; and

WHEREAS, on December 1, 2020, the COUNTY and CONTRACTOR entered into Amendment No. 1 to increase the contract amount by an additional \$72,800 for a new Agreement total of \$97,800; and

WHEREAS, on December 31, 2021, the Agreement expired by its terms; and

WHEREAS, County and CONTRACTOR wish to renew and amend the Agreement retroactive to January 1, 2022; and

WHEREAS, this Renewal and Amendment No. 2 is necessary due to County’s continued need for CONTRACTOR’s services; and

WHEREAS, County and CONTRACTOR wish to extend the term of this Agreement to June 30, 2022.

NOW THEREFORE, County and CONTRACTOR hereby agree as follows:

1. This Agreement is hereby renewed retroactive to January 1, 2022, and all of its prior terms and conditions shall be deemed to have been in effect continuously since that time.

2. Section 3.01. Section 3.01, TERM OF AGREEMENT is hereby amended and restated to read in its entirety as follows:

“3.01. The term of the Agreement is from December 1, 2019 through June 30, 2022, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both CONTRACTOR and County and with County signing last, and CONTRACTOR may not commence work before County signs the Agreement.”

3. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement are unchanged and unaffected by this Renewal and Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.

4. A copy of this Renewal and Amendment No. 2 shall be attached to the original Agreement executed by County on December 1, 2019.
