# ADVISORY REDISTRICTING COMMISSION ELIGIBILITY REQUIREMENTS

- Registered voter in Monterey County;
- Ability to serve from June through December 2021 and attend all meetings;
- Possess experience that demonstrates the ability to comprehend and apply the applicable State and Federal legal requirements;
- Possess experience that demonstrates analytical skills relevant to the redistricting process and voting rights;
- Ability to complete training regarding local government ethics, statement of economic interests, analytical skills, voting rights, county profile with demographic information, and mapping software;
- While serving, commissioners may not be a candidate for an elective office of the County; and
- While serving, commissioners may not endorse, work for, volunteer for, or make a campaign contribution to, a candidate for an elective office of the County.

While serving, commissioners may not serve as an officer of, employee of or paid consultant to:

- A campaign committee or a candidate for elective office of the County;
- A political party or as an elected or appointed member of a political party central committee; or
- An elected officer of the County.

## **ADVISORY REDISTRICTING COMMISSION REVISION OF ELIGIBILITY REQUIREMENTS**

- A person who is an elected official of Monterey County, or a family member, staff member, or paid campaign staff of an elected official of Monterey County, shall not be appointed to serve on the commission.
- Registered voter in Monterey County;
- Ability to serve through December 2021 and attend all meetings;
- Ability to complete training regarding local government ethics, statement of economic interests, analytical skills, voting rights, county profile with demographic information, and mapping software;

<b>July 27</b>	BOS Appoints ARC (Advisory Redistricting Commissioners)
<b>August 5</b>	ARC member training/orientation
<b>August 12</b>	ARC meeting to plan for COI (Communities of Interest) public meetings
<b>August 16</b>	Census Bureau releases data
<b>August 19</b>	ARC meeting to continue COI planning
<b>August 26 - Sept. 19</b>	ARC public meetings in each district; COI testimony and discussion Online mapping tools workshop for community
<b>September 23</b>	State (Calif. Statewide Database) scheduled to release redistricting data

<b>October 14</b>	Monterey County and LGDR will show draft maps (only need to wait 1 week)
<b>October 14, 21 &amp; 28, November 4 &amp; 13</b>	ARC holds a public meeting in each District (5) to review draft maps from public and demographers, and hear testimony from members of the public
<b>November 18</b>	ARC meeting (If necessary)
<b>November 30</b>	Special BOS PUBLIC HEARING - review ARC recommendations (ARC attending) <b>(*CSAC is Nov 29-Dec 3)</b>
<b>December 7</b>	BOS votes to adopt a plan - PUBLIC HEARING
<b>December 15</b>	<b>Legal deadline to adopt a plan that will be used for the June 2022 primary election</b>
