

AMENDMENT #3 TO AGREEMENT

COUNTY OF MONTEREY & SOCIAL POLICY RESEARCH ASSOCIATES INC.

WHEREAS, Social Policy Research Associates Inc., hereinafter called "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY" previously entered into an agreement dated December 18, 2012, for the provision of consultant services ("AGREEMENT"); and

WHEREAS, COUNTY and CONTRACTOR entered into Amendment #1 on April 22, 2013, to extend the Term of the AGREEMENT to June 30, 2014 and to modify the Scope of Services and increase compensation by an additional \$95,998 to a total amount not to exceed \$135,998; and

WHEREAS, COUNTY and CONTRACTOR entered into Amendment #2 on December 17, 2013, to add to the Scope of Services and increase compensation by an additional \$42,486 for a total amount not to exceed \$178,484; and

WHEREAS, COUNTY and CONTRACTOR wish to further amend the AGREEMENT to increase the total AGREEMENT financial compensation due to a change in the Scope of Work, renewing and extending the term of the agreement retroactive to July 1, 2014 for a total amount not to exceed \$178,484, and to extend the Term of the AGREEMENT;

NOW THEREFORE,

For valuable consideration, the sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. **PAYMENT PROVISIONS:** Section 2 of the AGREEMENT shall be amended by adding Exhibit A-3 and renewing and extending the term of the agreement for a total compensation of a not to exceed amount of \$178,484 for the term of the AGREEMENT.
2. **TERM OF AGREEMENT:** Section 3 of the AGREEMENT shall be amended by removing "The term of this Agreement is from September 11, 2012 through and including June 30, 2014", replacing it with "The term of this Agreement is from September 11, 2012 to June 30, 2015.
3. "EXHIBIT A-2 Additional Scope of Services" shall be amended with "Exhibit A-3 Additional Scope of Services" which includes additional services requested by the County. The revised Scope of Services shall be effective as of July 1, 2014. The County shall pay CONTRACTOR in accordance with the payment provisions set forth in the revised Scope of Services attached hereto as "Exhibit A-3 Additional Scope of Services."

4. Accept as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment NO. 3 and shall continue in full force and effect as set forth in the AGREEMENT.
5. A copy of this AMENDMENT NO. 3 shall be attached to the original AGREEMENT dated December 18, 2012; AMENDMENT NO. 1 dated April 22, 2013, and AMENDMENT NO. 2, dated December 17, 2013.







Overview

Based on the Strategic Plan for Gang Violence Prevention that was approved in May 2013, the County of Monterey’s commissioned SPR to facilitate the development of an Action Plan that moves the strategies to implementation and aligns the county’s investments in efforts to reduce gang violence.

In this next phase of the project (July 2014 – June 2015), SPR will continue to provide technical assistance to the backbone agency, conduct research and consulting services to develop program models, and develop funding opportunities for the County of Monterey and its core partners.

Task 1: Technical Assistance Services

SPR’s technical assistance will continue to provide national scans of relevant evidence-based practices, support in policy development, program analysis, facilitation of gang violence prevention design labs, and regular updates to the Action Plan. SPR will also provide other support to the MCGVP Coordinator and the CAO’s office role as Backbone Agency of the collective impact initiative.
