Acting as the Board of Directors of the Pajaro County Sanitation District:

- a. Receiving the report of delinquent fees having considered protests and objections to the report by property owners liable to be assessed for delinquent fees for the Pajaro County Sanitation District;
- b. Finding the action is not a project pursuant to Section 15378(b)(4) of the California Environmental Quality Act Guidelines;
- c. Confirming the draft report of delinquent fees for the Pajaro County Sanitation District; as identified in Exhibit A;
- d. Authorizing the delinquent fees as set forth in the confirmed report to constitute special assessments against the respective parcels of land to be collected at the same time and in the same manner as ordinary County ad valorem property taxes are collected; and
- e. Authorizing the Clerk of the Board of Supervisors to file a certified copy of the confirmed report with the Auditor – Controller.

WHEREAS, the Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District (PCSD) has enacted an Ordinance which provides for the collection of sewer service charges by use of a monthly billing system; and

WHEREAS, certain property owners in Pajaro County Sanitation District (Exhibit A) have allowed past due balances to accumulate; and

WHEREAS, Ordinance No. 05054, established procedures for collecting delinquent fees for the PCSD , allowing for the collection of delinquent fees and a lien transfer fee as special assessments constituting a lien on the property for the same of such delinquent fees; and

WHEREAS, it is desirable that past due assessments for sewer service be collected; and

WHEREAS, this action is not a project pursuant to Section 15378(b)(4) of the California Environmental Quality Act Guidelines; and

WHEREAS, the Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District conducted a public hearing, heard the report, and considered any property owner protests and objections to the report to satisfy the requirements of Ordinance No. 05054 regarding procedures for collection of delinquent fees.

NOW, THEREFORE, BE IT RESOLVED by the Monterey County Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District, hereby:

1. Confirms the report of delinquent fees for the Pajaro County Sanitation District, as identified in Exhibit A.
2. Finds the action is not a project pursuant to Section 15378(b)(4) of the California Environmental Quality Act Guidelines;

3. Authorizes the delinquent fees as set forth in the confirmed report to constitute special assessments against the respective parcels of land to be collected at the time and in the same manner as ordinary county ad valorem property taxes are collected.

4. Authorizes the Clerk of the Board of Supervisors to file a certified copy of the confirmed report with the Auditor-Controller.
