**Taxport ACA Security –** Sovos Compliance has comprehensive business continuity and a disaster recovery plan to ensure your data is secure and available when you need it most. We certify to the ISO27001 Information Security Management Standard to ensure our client's data security, availability, and confidentiality requirements are met. We utilize SSAE 16 SOC 1 audited data centers and advanced encryption technology ensuring data security, including transmission of data and data-at-rest encryption (FIPS 140-2 Level 3 Certified) within our software as a service environment.
