#### Agreement No. A-14492, Amendment No. 1

A motion was made by Supervisor Luis A. Alejo, seconded by Supervisor Chris Lopez to:

- a. Authorize the Deputy Purchasing Agent for Natividad Medical Center (NMC) or his designee to execute the First Amendment to the Professional Services Agreement with The Regents of the University of California, a public corporation, on behalf of the University of California, San Francisco, School of Medicine, Department of Pediatrics (UCSF) to provide pediatric cardiology services extending the term by twenty-four months for a revised full agreement term of January 1, 2018 to December 31, 2020, and adding \$200,000 for a revised total not to exceed amount of \$300,000 in the aggregate; and
- b. Authorize the Deputy Purchasing Agent for NMC to sign up to three (3) future amendments to this agreement where the total amendments do not significantly change the scope of work and do not cause an increase of more than ten percent 10% (\$10,000) of the original contract amount.



**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT  
BETWEEN  
THE REGENTS OF THE UNIVERSITY OF CALIFORNIA  
AND  
NATIVIDAD MEDICAL CENTER**

THIS FIRST AMENDMENT is entered into by and between The Regents of The University of California, on behalf of the University of California, San Francisco, School of Medicine, Department of Pediatrics, (hereinafter collectively known as "UCSF"), and the County of Monterey on behalf of Natividad Medical Center (hereinafter "HOSPITAL"), effective September 1, 2019.

WHEREAS, on or about January 1, 2018, UCSF and HOSPITAL entered into a Professional Services Agreement (the "Agreement"); and

WHEREAS, the Agreement provides that it may be amended at any time by mutual written consent of the parties; and

NOW THEREFORE, in consideration of the foregoing and the mutual promises set forth below, the parties agree as follows:

1. Section 4.1 Term. shall be deleted in its entirety and replaced with the following language:  
  
"4.1 Term. This Agreement shall become effective on January 1, 2018 (the "Effective Date") and shall continue until December 31, 2020 (the "Expiration Date"), subject to the termination provisions of this Agreement."
2. Section 3.1, Compensation to UCSF for Contract Services, shall be deleted in its entirety and replaced with the following language:  
  
"3.1 Compensation to UCSF for Contract Services. HOSPITAL shall pay to UCSF the amount determined in accordance with Exhibit 3 (the "Compensation"), upon the terms and conditions set forth therein. The total amount payable by Hospital to UCSF under this Agreement shall not exceed the sum of Three Hundred Thousand Dollars (\$300,000)."
3. Except as modified above, all terms and conditions of the Agreement, including all previous amendments, if any, shall remain in full force and effect.
