If you read down the chain of emails below, you will see that we were told that we had a 2 year extension in 2021. (see Craig Spencer email dated 10-15-2021). I started trying to confirm our status and get an extension again in 2023. I never heard back from anyone. This is ridiculous...

PLN 180517 was approved on 10-15-19, giving it an expiration of 2021.

PLN 180527 was approved 4-27-2020, giving it an expiration of 2022.

As you can see from reading the email chain, we did not get any kind of response from Kenny Taylor regarding our requests, even after Craig stepped in and told him to send the documents we needed.

I requested the extension multiple times, certain documents have been recorded. (Permit Approval and Indem.)

A title issue arose that had to be dealt with by the family so I requested the extension but did not ever get a satisfactory reply. Kenny did talk to me on the phone once to say that he would "note in the file" that an extension was requested. But I never saw a note regarding or confirming it. I have notes I my file that say he told me that there was a 3 year extension.

I had a hard time getting the man to email me or to talk to me on the phone. It has been extremely frustrating.
