**AMENDMENT NO. 1
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN COUNTY OF MONTEREY AND
QUINN POWER SYSTEMS**

THIS AMENDMENT NO. 1 to the Professional Services Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Quinn Power Systems (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the County and CONTRACTOR are referred to as the "Parties").

WHEREAS, CONTRACTOR entered into a Professional Services Agreement with County on September 12, 2012 (hereinafter, "Agreement"); and

WHEREAS, the County has a continued need for annual preventative maintenance and repairs on County emergency generators; and

WHEREAS, the County has identified an additional emergency generator, located at the Monterey County Health Department, which requires annual preventative maintenance and repairs to be included in the Agreement for Fiscal Year 2013 – 2014 (July 1, 2013 – June 30, 2014); and

WHEREAS, the Parties wish to amend the Agreement to increase the amount by \$2,627.00 to allow CONTRACTOR to provide services identified in the Agreement and as amended by this Amendment No. 1.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the second sentence of Paragraph 2, "Payments by County", to read as follows:

The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$32,627.00.

2. Amend Paragraph 4, "Additional Provisions/Exhibits", by replacing "Exhibit B – Preventative Maintenance Schedule" with "Exhibit B-1 – Preventative Maintenance Schedule".
3. In all places within the Agreement, any reference to Exhibit B – Preventative Maintenance Schedule, is hereby replaced with Exhibit B-1 – Preventative Maintenance Schedule.


4. All other terms and conditions of the Agreement remain unchanged and in full force.




