She first began as a Typist Clerk I in the Revenue and Recovery Department (e.g., earning \$4.62 cents an hour). She then moved up to Typist Clerk II, Risk Management Division. Once within the Risk Management team, due to her attention to detail and her strong work ethic, Lucy continued to advance to Senior Typist Clerk in 1983; and later, was promoted to Benefits Specialist – Confidential, in 1990; and

WHEREAS, *Lucy Raney* was later promoted to Analyst and then subsequently became Associate Risk and Benefits Analyst in 2008. She was instrumental in implementing efficient and cost-effective retirements, benefits and risk management programs. She continued to develop her specialization in the Risk Management Division. To many County of Monterey employees, Lucy was their support and informed voice behind complex and detailed paperwork; and
